NOTICE:

After the payment is made, your travel shall be considered as definite, and the changes you will make in your reservation record and flight tickets shall be subject to the following rules. The passenger accepts, declares and undertakes to obey the rules written below.
PASSENGER MUST BE AT THE AIRPORT 3 HOURS BEFORE SCHEDULED DEPARTURE TIME AND HAVE TO COMPLETE CHECK-IN AND BAGGAGE FORMALITIES 45 MINUTES PRIOR TO THE SCHEDULED DEPARTURE TIME. OTHERWISE PASSENGER LOSE ALL THEIR RIGHTS RELATING TO THIS TICKET.

ISSUED TICKET RULES ARE AS BELOW :

1 - Name change: Name change is not allowed. Ticket can not be assigned to another passenger.

2 - Refund/Rebooking:

Business Class (C) Class Before / after scheduled departure time, no penalty applies.

Economy Class (Y) Class: a) Up to 24 hours before departure, 50 USD penalty for each segment. b.) Within 24 hours-scheduled departure time 100 USD penalty for each segment. c.) After departure %50 penalty for each segment. (E-K-P-R-T-B-H Classes) a) Up to 24 hours before departure 50 USD penalty for each segment. b.) Within 24-3 hours before departure 100 USD penalty for each segment. c.) As from 3 hours before departure not allowed.

H Class is used only for workers who works in Iraq and their families (wife/husband and sun/douughter). On the check-in desk, the passenger has to show worker ID which is given from Iraq government and company certificate which should mention that the person is working for that company in Iraq and should be stamped and signed. OTHERWISE THE PASSENGER CAN NOT USE THE WORKER TICKET (H CLASS). The passenger could fly if he/she will pay the fare difference between standart fare and worker fare.

3 - Rerouting: Not allowed.

4 - Free baggage allowance: is 20 kg for Y Class, 30 kg. for C Class. Passenger under 2 years (infant) has no baggage allowance.

5 - In case of reservation changes and open ticket confirmation: the fare will be recalculated in accordance with the new required flight/class fare. The system will automatically charge/refund difference between the original and the new fare.

6 - Ticket validity: Tickets are valid for 1 year after the issuing date. After 1 year, passenger lose all their rights related to the unused tickets.

7 - In case of dispute, the electronic records of Atlasjet shall be valid.
